ACTION

The Chairman reported back on the Clerk's appraisal and was pleased with her huge achievement which she has gained this year.

KCC Matters – Councillor Gough matters

New and high priority outstanding issues for the PC for discussion

Childsbridge Lane Railway Bridge incident – This is an important priority due to safety. KCC to look at the extension of speed limit through traffic counts. The Parish Council would like to take this forward but due to COVID-19 this is on hold until traffic returns to normal.

Pending CV-19 Traffic count

Ongoing highway matters

Gulleys around Meadowlands, Zambra Way and Bentleys Meadow are cleansed and completed and checked.

2 Gulleys needs a job raised and this is on a 28 day order.

A25 SID column needs to be reinstated; this is currently on hold due to COVID-19 as traffic counts are required.

Pending CV-19 Traffic count

Mr Bourne to provide SID data for Childsbridge Lane.

A public bridleway sign on Carters Hill, One Tree Hill requires the post to be put back into the ground, Councillor Gough reported that this is on the list of jobs to be done.

3 blocked rainwater drains, Underriver House Road, Councillor Gough reported a range of jobs that have not been completed and that this has now been raised along with Carters Hill and Rooks Hill. Councillor Gough reported on an additional log in portal for councillors.

Highway Schemes

Resurfacing of Bank Lane - KCC are checking drainage and ditches some of which are in private ownership and looking to see if this will cause any issues for KCC.

Copse Bank/Ashplatt Footpath

The maintenance on Copse Bank footpath still

needs attention. Councillor Gough reported that contractors visited site on 25 June and there is movement in this area and that plans are being taken forward.

A25 temporary relaxation of HGV Vehicles

A resident reported a lot of traffic through the night on the A25 thought to be due to the relaxation of drivers' hours under COVID-19 but is ongoing KCC is trying to ensure heavy lorries keep to the main trunk roads as far as possible into their journeys, but for Seal the problem is that this an A class road and the problem also relates to the lack of slip roads onto the M25 Councillor Gough reported that he will take this up again.

Household Waste

Councillor Gough reported that a new booking system to replace the existing one which is considerably more user friendly and expanding up to 33,000 slots available, which will allow people to go twice a month and more. The system has proved successful and avoided queues and has maintained social distancing and worked well.

Department of Transport

Department of Transport had released money for active travel, walking, cycling etc and KCC has to bid for this and secured 100% on first tranche £1.6 million and working on a second tranche for £6.4million KCC will look at schemes in our area. KCC looking to spend on priority schemes, speed limits, reserve spaces and lanes. Public Transport Sector are under pressure, fewer people using the public transport and using their cars. KCC want to boost active travel and support and are addressing the implications of returning back to school in September.

Other Matters Requiring Discussion and Action

Highway Improvement Plan

The Council felt frustrated by the lack of success in the HIP so far. It was agreed that there needs to be an understanding of what can be done and looking at neighbouring Parish HIPs might help. Mr Brown will take the lead on the HIP with the help of Mr Haslam and Mr Penn, move this forward with a view to meeting Mr Bineham in August /September. Councillor Hogarth mentioned rationing 40mph down to 30mph in Seal to Bessels Green and working with Linda Larter at Sevenoaks Town Council on this. Mr Brown raised that we should focus on the old points raised in our HIP this year and any new points will need to be raised on the next HIP.

Traffic around the Fawke Common entrance to Knole Park

It appears that the signage along St Julians road preventing parking was helping. SDC are offering free parking at the weekend and this is encouraged. There are also a considerable amount of cars parking in One Tree Hill and on Fawke Wood Road to St Julians Road, which causes the lanes to narrow. It is felt that this is going to be an ongoing problem for the future. It was suggested to write and organise a meeting with STC to discuss issues with parking around Knole area and the parish.

Bridle Lane/Park Lane

A residents raised on double yellow lines on access routes to Bridle Lane path off Park Lane, double yellow lines on Park Lane opposite entrance to Bridle Lane for large vehicles like fire engines to be able to complete and make the turn needed to access Bridle Lane path. It was suggested that no parking signs might help but it is part of the wider problem that needs addressing.

Park Lane

Park Lane, Column 30 was crashed into some time ago and UKPN had to come out to make the column safe, so it could be replaced. We have now had confirmation that to supply and install a 5m

galvanised column SL8 LED Lantern to be £1,175 plus VAT. This is currently covered under our insurance and the clerk should proceed with the work.

Playground Equipment in Seal Recreation Ground

Due to government guidelines, the play equipment is currently closed but measures are being put in place so that the playgrounds at both Seal and Bitchet Green can open shortly. The Parish Council thanked Mr Tavare for the thorough review of what is required to open up under the Covid requirements and approved his posters with minor amendments, The Risk Assessment has been drafted for COVID and the Pavilion and will be agreed by email and circulated to Councillors.

Seal Recreation Ground Car Park

There are wooden posts which have been knocked down. The Council to repair the wooden post which are broken.

Seal Allotments

The Parish Council has been asked whether we could repair the northern boundary of the Seal Village Allotments. This is the boundary which runs adjacent with Wibble Way footpath which runs to the recreation ground from Childsbridge Lane and carries on along the back of Zambra Way this is to secure their site from the footpath. The Parish Council are considering work to be done.

Mr Brown has prepared a draft of the website accessibility statement and we are looking for a third party to test the site before we publish.

South East Water

The Clerk has been emailed to ask whether we would publicise the importance of saving water on either parish magazine, noticeboards or website. If there are materials that are easily promoted the Clerk can consider this, but it is not felt to be a priority at this time.

Scouts

The Group Scout Leader would like to organise for cubs to give something back to the community. They are planning on this being two-fold and something the young people can manage with their parent/guardian as like many organisations they can still not participate in face to face Scouting. They would like the Cubs to place posters around the village actively reminding people to a) put rubbish in the bins b) take rubbish home and most importantly not to drop it. They plan to follow this up with the young people using litter pickers and gloves then picking up rubbish on their walls around the village. The Parish Council agreed that this was positive activity and wished to encourage the younger generation to engage in such matters and agreed subject to the Scouts complying with their own COVID and regular risk assessments,

HM prison and probation Service, a community payback scheme, unpaid work 40 to 300 hours. Examples of work remove graffiti, charity work, cleaning wasteland, decorating public buildings. The Parish Council confirmed we would like to apply for this service in our parish.

Local Housing Needs

The SDC Housing Enabling Officer had provided a progress report on the 3 social housing sites in the Parish.

It was agreed that Mr Martin would draft a letter to SDC confirming the Parish Council's support for their development as rural exception sites for social housing.

The disposal of land behind Sealcroft cottages by SDC has been deferred pending clarification of the proposal, and the Parish Council should conform that its support for development of this site depends on its use for social housing.

The Parish Council has also been asked to comment on pre-application plans for Mills Crescent. Mr Martin will circulate the plans as pdf files, and Councillors should now give him their comments.

A walk organised at Bitchet Common will be arranged when the current COVID-19 restrictions are lifted.

Parish Bus Shelter Grant Application for the financial year 2020/21

Kent County Council (KCC) runs a Parish Bus Stop Shelter Grant (PBSSG) scheme. Councillors had been asked to bring any proposals for funding to the meeting and there were none to report at the last meeting. It was noted that the bus stop on the A25 was full of leaves and whether the Parish Council volunteers could clear them up.

Bonfires in the Parish

To remind residents to be considerate when contemplating a garden fire in particular on hot days or conditions when smoke will drift some distance and cause a nuisance.

New Funding for small businesses

Small businesses who did not qualify for Coronavirus Grant funding up to now can apply for a new source of financial help. SDC has £1.2 m of additional government funding to help small businesses affected by the COVID-19 pandemic and is encouraging them to apply for a share of the money. Funding is open to Sevenoaks District based business with less than 50 employees and a turnover of less than £10.2 m. Although businesses that qualified for Small Business Grants and Retail Hospitality and Leisure Grants cannot apply. Businesses should visit
